# Eligibility

- <u>All</u> publicly funded law enforcement agencies with 50 or less sworn officers (small); or
- <u>All</u> publicly funded rural law enforcement agencies; or\*
- <u>All</u> Federally recognized tribal law enforcement agencies\*

\* These agencies could have more than 50 sworn officers.



# Eligibility


Micro-grant funds are to be used for the reimbursement of BWCs and related costs purchased/leased after JANUARY 1, 2025



# **BUDGET MADE EASY**

#### **MATCHING TYPES:**

**CASH MATCH**: Non-federal funds spent for projectrelated costs (equipment, supplies, consultants)



**IN-KIND MATCH**: In-kind funds (staff time, training, policy development, management etc.) supporting the body-worn camera program purchased for the SRT micro-grant

# Tips for Improving Your SRT BWC Budget

Budget Example 1

- 3 BWCs
- BWC Quote Total: \$10,000

SRT BWC Budget Entries:

- Equipment Award Request: \$6,000
- Equipment Non-fed Match: \$4,000
- Personnel Non-fed Match: \$2,000

(S) (S) (S) Award Request Within Cap (\$2,000 per BWC)

1:1 Match Requirement

**In-Kind Match** 

# PERSONNEL BUDGET

Chief Deputy Jones will serve as the BWC Program Director

- BWC Procurement
- Policy Development
- Officer Training

5% of \$50,000 annual salary makes up remaining \$2,000 match
